On **October 22, 2022**, at the Homeowner Annual Meeting, ballots will be counted, and the outcome announced. The cutoff time for submitting ballots is noon on that day in the lodge.

BOARD MEETING UPDATES

Financials

At the Board's July 16, 2022 meeting, the Board reviewed the financials for Carnelian Woods and voted to increase dues by 10%, to \$1,578 per quarter, commencing October 1, 2022. The new dues plus quarterly assessment of \$438 brings the quarterly invoice to \$2,016.

We are also no longer accepting HOA payment through Mutual of Omaha (CIT). The two acceptable ways to pay now are writing checks to "Carnelian Woods" or using the Zelle Electronic Banking system. Instructions for this were mailed out to all homeowners on October 3rd.

Forestry

Our Firewise renewal was submitted and approved.

Fran and Don met with April Shackelford from North Tahoe Fire and discussed the final steps in completing the treatment on our property including the area of the creek that is the association's responsibility.

According to April, the piles from the larger treatment will be burned, likely winter 23/24 and should take about five days. A NTFD staffer will be on site during the process. April is working towards moving piles away from areas near the units. If there are any piles under trees, April will ensure that they are moved before burning.

Diane attended the Tahoe Summit on behalf of our association and Fire Adapted Communities (Firewise). Fran attended the meeting with Agate Bay and Carnelian Woods communities where April was available to address concerns.

Outreach

A Memorandum of Understanding (MOU) between Placer County, Town of Truckee, NorthStar Community Service District & other local jurisdictions was executed for establishment of the North Tahoe Truckee Biomass Task Force to find local solutions for the biomass byproducts of fuel management programs which span across jurisdictional lines. The recommendation for reopening the feasibility analysis on the County Cabin Creek Biomass project has been identified as one of its highest priorities to finding solutions for the disposal of biomass from residential defensible space and forest management programs. At present the lack of local biomass disposal options is pushing some programs to leave biomass material on the forest floors which increases the fuel loads for potential wildfires. The MOU hopes to share resources & costs, create educational outreach, and provide regional solutions to biomass related issues. The plan has the potential to create renewable energy/heating, centralize biomass processing, reduce the overall cost of biomass disposal, and reduce greenhouse gas emissions from open pile burning while reducing the potential risk of wildfires.
