## **Lake Tahoe Restoration Act**

Last fall the U. S. Senate passed the Lake Tahoe Restoration Act as part of a vote to adopt the \$10 billion Water Resources Development Act of 2016. It passed with a 95-3 vote.

The bipartisan Lake Tahoe Restoration Act would authorize up to \$415 million in federal funding over 10 years for federal, state, and local partners in the Tahoe Basin to continue their work to reduce wildfire threats, improve water clarity, jumpstart innovative infrastructure projects, combat aquatic invasive species, and reduce the Lahontan cutthroat trout.

#### Tahoe Fund

In January the nonprofit Tahoe Fund announced that private donors met a \$50,000 matching grant for a new Environmental Venture Trust, a program designed to provide early stage seed funding to innovation projects around the Tahoe Basin. Funding will be provided for innovative pilot projects addressing issues such as tree mortality, aquatic invasive species, the Lake's water clarity, transportation options, and outdoor recreation enhancement and stewardship.
