Note: **Approval of a budget** requires a quorum of 50%, or in our case, 60 units need to be present and/or have sent in their proxy. Then that group needs to pass, having a simple majority, which would be 31 units. So the actual percentage if calculated against the total 118 units could be as low as 27% of the total units. Should the above not occur then an automatic increase of 3% takes place.

North Lake Tahoe Updates

The newly-formed "Local Outreach Committee" is led by Kathy Witt, who has owned CW#154 for 11 years. Recently retired from the health care field, she and her committee (once established) will represent Carnelian Woods homeowners on issues that impact our association.

The first phase of activities for this committee has commenced. It is mainly for research and networking with key professionals from the Tahoe Regional Planning Agency (TRPA), the Board of Supervisors and the League to Save Lake Tahoe. Each of these entities have multiple agenda items (as witnessed while attending TRPA and Supervisor Jennifer Montgomery's meetings) that may impact Carnelian Woods: transportation planning (bike path behind Carnelian Woods);environmental planning (lake clarity); landscape restoration strategies (on west shore now, but will need to discover if there are plans for the north shore); and other related issues.

One of the most important areas that require close attention is the Environmental Impact documentation when a new project is considered. Supervisor Montgomery underscored the need to voice opinions early in projects that are important to Carnelian Woods. Thanks go to Holly Muenzer (#35) and Heidi Paoli (#111) who already have provided valuable assistance with this new committee's activities.
