Homeowners: Please remember to turn your main water valve off and on occasionally so it continues to work. If this is not done often, the valve will freezeup and your unit will not have the ability to have the water shut off. Also, Winter is rapidly approaching and does your unit have a FREEZE ALERT SYSTEM installed? Last year several units had extensive water damage due to frozen water pipes. These could have been avoided if a FREEZE ALERT SYSTEM had been installed. Please ask Don or Serge about this so you too can be protected against broken pipes. Just a reminder, be sure your thermostat stays set at 60 degrees through the winter months!

The Local Outreach Committee has been established with new members who are greatly appreciated. Heidi Paoli (#111) Jan Babb (#16) Karen Cleland (#152) Ruth Dworsky (#140) and Diane Hopkinson (#26).

The Local Outreach Committee is a newly formed committee to keep the Carnelian Woods Board of Directors and ultimately the homeowners informed of local events and regulatory activities that will impact Carnelian Woods. All of us are in the discovery phase of this newly-formed committee.

We plan to focus our efforts on three items (1) The bike path that is in the process of being determined (2) Housing issues that are impacting employees in the Basin -The Mountain Housing Council with 29 local individuals and businesses is addressing this issue (3) Transportation issues (to decrease the use of cars) are mainly being addressed by all of the contacts. The regulatory bodies are Placer County Board of Supervisors, the North Tahoe Regional Advisory Council, the Tahoe Regional Planning Agency (TRPA), and the League to Save Lake Tahoe.

Forestry Report - Celia Barry

In August a contractor removed 70 dead trees from the 17 acre "undeveloped lots" area at the end of Silver Pine Drive. This activity is supported with Fire Safe Council grant funds. Our staff also removed another 30 to 40 dead trees and the staff and homeowners raked and removed approximately 400 yards of flammable material (pine needles and cones, dead branches) this year.

On September 12, 2018, Mike Vollmer, Forest Fuels Coordinator for North Tahoe Fire, and Eric Horntvedt, Defensible Space Inspector for North Tahoe Fire walked the Carnelian Woods property to assess our wildfire vulnerability. Vollmer and Horntvedt could find no issues for remediation noting that the construction materials used for the Carnelian Woods Association buildings and decks, together with the removal of trees and flammable brush created a solid defensible space. Our staff and homeowners are to be congratulated for continuing our aggressive efforts to keep our homes safe!



We also hosted a "Fire Adapted Communities" educational event on September 12th in front of our lodge. Carlie Teague and Brenna Blessing from Tahoe Resource Conservation District brought educational materials about preventing wildfires at Lake Tahoe.

Finally, if there is a fire or other emergency requiring our evacuation, urgent notification will be key to our survival. Please take a few minutes to register your cell phone numbers(s) with <u>www.placer-alert.org</u>. And please also consider downloading the smartphone app from Cal Fire called Ready for Wildfire. It has a lot of information about preparing for wildfire and has current wildfire information for California. You can also set the app to notify you if there is a wildfire near Carnelian Bay and any other counties in California. Finally, you can set the app so that it will notify you if there are any wildfires within 30 miles of your cell phone.
